# **TERMS AND CONDITIONS FOR ONLINE PAYMENTS**

#### About AAINA

Founded in 1998, Aaina is today recognized as one of the front-ranking NGOs of Odisha working in the field of disability. Aaina envisages an inclusive society where each person has an identity, independence and exercises his/her rights with dignity and equality especially persons with disabilities, women, children, elderly, ultra-poor and other socially excluded groups.

#### 1. Contest Entry Details

- (viii)Receipts for all payments / donations will be generated by BillDesk, it is the responsibility of the donor / contest applicant to download the receipt.

## 3. Debit/Credit Card, Bank Account Details:

The Donor / Contest Applicant agrees that the debit/credit card details provided by him/ her for use of the aforesaid Service(s) must be correct and accurate and that the Donor / Contest Applicant shall not use a Debit/ credit card, that is not lawfully owned by him/ her or the use of which is not authorized by the lawful owner thereof. The Donor / Contest Applicant further agrees and undertakes to Provide correct and valid debit/credit card details.

The Donor / Contest Applicant may pay his/ her fees/donation to Aaina by using a debit/credit card or through online banking account. The Donor / Contest Applicant warrants, agrees and confirms that when he/ she initiates a payment transaction and/or issues an online payment instruction and provides his/ her card / bank details:

- (iii) The student/candidate is responsible to ensure that sufficient credit is available on the nominated card/ bank account at the time of making the payment to permit the Payment of the dues payable or fees dues selected by the Donor / Contest Applicant inclusive of the applicable Fee.

Any dispute is subject to jurisdiction of SDJM, Bhubaneswar only. The relation between donor/contest applicant and Aaina is not that of a consumer and a service provider (Bill Desk).

# 8. Refund/Cancellation Policy:

Contest Fees once paid will not be refunded under any circumstances. However, in case of incongruent payments the donors may contact Aaina. Based on the resolution of the issue the appropriate action will be initiated. After verification of details, the service provider (Bill Desk) will resolve the issues.
